Peer Support Workers are parents with lived experience of child protection and out-of-home care systems, including restoration and working with lawyers, workers, and carers. This is a combination paid-voluntary job and includes support and supervision with a social worker.

## Parent Peer Support Project (PPSP)

Project Report Innovative pilot project in 2018-20 which informed our peer support service. A practice and research partnership with Newcastle Law School and Life Without Barriers, funded by NSW Law and Justice Foundation. Linked to peer reviewed studies about parent, peer, and practitioner experiences.
