# LEGAL AID FOR CARE AND PROTECTION MATTERS

when your child was removed and is care with a foster carer or kinship carer.

## BEFORE YOU START

Legal Aid may be available to adults with parental responsibility, or otherwise significant to the child, for most types of care and protection matters in New South Wales

**You should get legal advice before you fill in your application form.** You could get help with your legal problem without going to court.

You can call **Legal Access** on 1300 888 529. If your lawyers says you need a grant of legal aid, complete a legal aid application form. Your lawyer may be able to submit your application for you.

## ELIGIBILITY REQUIREMENTS

- ◆ You have had parental responsibility for the child or have had parental responsibility removed
- ◆ You have a genuine concern for the safety, welfare and well being of the child
- ◆ The child will benefit from you receiving legal aid
- ◆ Legal Aid NSW will assess your income and assets
- ◆ Legal Aid NSW will make an assessment on the nature of your legal problem and the likelihood of success
